BOARD MINUTES - July 16, 2025

TANTERRA HOMEOWNERS ASSOCIATION, INC. Board of Directors Meeting

July 16, 2025 (Approved 8/20/2025) ZOOM Meeting

1. CALL TO ORDER/ESTABLISH QUORUM

The Meeting was called to order at 7:31 PM by President McEwen.

2. ADDITIONS/CHANGES TO THE AGENDA by the BOD

1) Social Committee information in Agenda deleted. 2) New Business: Annual Meeting Date.

3. HOMEOWNER'S FORUM

No questions or comments from Homeowners in attendance.

4. APPROVAL OF MINUTES

A motion was made by Glenn Wasik to approve the May 21, 2025 BOD Meeting Minutes. The motion was seconded by Julie Funt. The motion passed unanimously. A motion was made by Glenn Wasik to approve the June 18, 2025 BOD Meeting Minutes, as amended. The motion was seconded by Julie Funt. The motion passed unanimously

5. REVIEW OF FINANCIALS

Jim Cagley reviewed the outstanding payments and dispositions. There are currently 7 unpaid Homeowners and there are six (6) extensions of payment. There are six (6) liens with the attorney for further action. Reported major expenditures since the last meeting: Pool Management Fees - \$30,100.00; Pool Utilities - \$3,564.98; Grounds - Mowing - \$2,400.00; and Pool Trash Collection - \$1,290.30. The Swim & Dive Team account balance is \$73,847.13. Jim Cagley announced that the Finance Committee Meeting to prepare the 2026 Budget will be held on September 4, 2025, at 6:00pm. Notice of this Meeting will be posted on the HOA Website and Facebook Page.

6. REPORTS

Architectural Committee – Wayne Johnson

Wayne Johnson reported there were six (4) approvals for an architectural change at the July 2025 Meetings, including windows, fence, screened-in porch, driveway, siding and paint on an addition. All 2025 Architectural Violations have been closed out, there remains one (1) 2024 violation that is being worked on. Landscape inspections will occur starting on July 19, 2025.

Pool Committee – Wayne Johnson

No Pool Committee Meeting was held during this last period.

Wayne Johnson reported that an anonymous complaint had been received about the cleanliness of the Pool. He noted that the Pool is very crowded with Swim and Dive Team members during the week and they had not been cleaning up after themselves and there were crowds on the weekends. Glenn Wasik, a former Swim Team Rep, noted that the Swim and Dive Team should be cleaning up after themselves before they leave after each practice and meet and that he enforced this as a Team Rep, as it is the responsibility of the Team Reps to make sure the team members and parents do not leave the Pool in a messy or dirty condition.

Grounds Committee – Diana Cortijo

No Grounds Committee Meeting held during this last period.

7. NEW BUSINESS

Following a discussion about the unfortunate inability of a Board Member to continue serving due to an unexpected medical condition, a motion was made by Jim Cagley to remove Director Jodie Siarkas from the Board pursuant to Article IV, Section 3 of the By-Laws and this motion was seconded by Glenn Wasik. The motion passed unanimously. Following a discussion, a motion was made by Glen McEwen pursuant to Article IV, Section 3 of the By-Laws to select Homeowner Justin Jordan as the successor Board Director of Jodie Siarkas to serve her unexpired term. The motion was seconded by Glenn Wasik. The motion passed unanimously.

Following a discussion, a motion was made by Jim Cagley to hold the Annual Meeting and Election on November 19, 2025, at 7:00 PM. The motion was seconded by Jim Wenhold and it passed unanimously.

Glen McEwen provided an update on the 2024 Tanterra HOA Financial Audit and indicated we hope to have it by the next BOD Meeting.

8. OLD BUSINESS

Glen McEwen discussed the latest draft of the new Reserve Fund Study. President McEwen and Vice President Johnson have met on multiple occasions to clarify information and question perceived inaccuracies in projected costs in the draft study. There efforts have resulted in a reduction of the projected annual HOA contribution to the Reserve Fund from approximately \$96,000 (over twice the current amount of \$47,027) to approximately \$50,000. Jim Cagley pointed out that Article IV, Section 2 of the Re-Stated Declaration of Covenants, Conditions and Restrictions permits an increase of only 6% of the annual HOA assessment, which would have allowed only an additional \$12,636 in income for total HOA revenue in 2026. He thanked Glen and Wayne for using their knowledge and experience in developing the new Reserve Fund so as to avoid a potential future separate Homeowner assessment in addition to annual HOA dues.

9. ADJOURNMENT

A motion was made by Glenn Wasik to adjourn. The motion was seconded by Jim Wenhold. The motion passed unanimously, and the **meeting adjourned at 8:18 PM**.

2025 Election Rules

The Election Committee is comprised of Jim Frye, Julie Funt and Beth Murray. These individuals will be checking in homeowners and/or examining and tabulating the votes.

The first 10 minutes of the Annual Meeting, currently scheduled for November 19, 2025, will be allotted for a "meet and greet" of the candidates for the Board of Directors. During the Annual Meeting, and prior to the Election voting, each candidate will be allowed up to two minutes to explain why they should be elected to the Board. Comments will be kept to why they are suited for the position, what experience they have that would make them a good Board Member, how long they have lived in the neighborhood, what they would like the Board to do, etc. Essentially, they will be providing the Candidate Bio information that was included in the Newsletter. Other candidate backing and/or bashing will not be permitted (one candidate cannot say anything good or bad about another candidate's position on an issue). Candidates will be speaking in alphabetical order per their last name.

The Candidates receiving the highest three vote totals, including absentee ballot votes, will be declared the winners of the Election. In the event of a tie between the 3rd place finishers, the following will take place: in the event one of the candidates does not acquiesce to allow the other to have the Board Member position, a run-off election between the tying candidates will take place by a secret ballot at the Annual Meeting. No additional comments by the candidates will be allowed. Slips of paper will be distributed and homeowners in attendance will vote (one per household) by writing the name of the candidate they are voting for on the slip and depositing it in the ballot box. These votes will be added to absentee ballot votes that were received for each run-off candidate and the highest vote total will receive the position. In the event a tie still remains at this point, a coin flip will determine the winner.

Following the announcement of the Election Results, those members of the Election Committee attending the Annual Meeting, currently scheduled for November 19, 2025, will certify the Election Results.

Nomination for 2025 Election Rules

The 2025 Nominating Committee for the 2025 Board of Directors Election is comprised of Jim Wenhold (Chair), Diana Cortijo and Jim Frye. Pursuant to Article V, Section 1 of the By-Laws of Tanterra Homeowners Association, Inc., "The Nominating Committee shall make as many nominations for election to the Board of Directors as it shall in its discretion determine, but not less than the number of vacancies that are to be filled."

To fulfill its duties, the Nominating Committee will be reviewing the potential candidates for approval for nomination to ensure that they are eligible and in good standing. The Nominating Committee will publish a Call for Candidates for the 2025 Board of Directors Election in the October 2025 Tanterra Today.

The Nominating Committee will also be reviewing for approval all Candidate Biographies (Bios) prior to their submission for publication in the Tanterra Today and placement on the Tanterra HOA website and/or Tanterra HOA Facebook Page. Candidate Bios are optional for each potential candidate and must be submitted to the Nominating Committee Chair by 3:00 PM on October 18, 2025, so these may be distributed to the Nominating Committee members prior to the Nominating Committee Meeting, currently scheduled for 7:00 PM on October 21, 2025.

The Candidate Bios should be limited to information about potential candidates only and why they are suited for the position sought, what experience they have that would make them a good Board Member, how long they have lived in the neighborhood, what they would like the Board to do, etc. These Candidate Bios are designed to provide basic biographical information and are not campaign literature. Because these Candidate Bios will be mailed and posted on the Tanterra website, the HOA could potentially be liable for publishing defamatory statements about third parties and therefore the Candidate Bios should not be defamatory, insulting, bashing or denigrating toward other candidates or critical towards any specifically named individuals. Any potential Candidate submitting a Candidate Bio for publication that the Nominating Committee determines contains such type information will be provided a final option to resubmit for approval a different Candidate Bio until 10:00 AM on the day after the Nominating Committee meets, currently expected to be October 22, 2025 at 10:00 AM. If not acceptably resubmitted, the Bio is rejected.

The Chair of the Nominating Committee will provide the President and the Editor of the Tanterra Today with the names of all approved Election Candidates within 48 hours after the Nominating Committee Meeting for approval of nominations for election to the Board of Directors.

Election Candidates will have the opportunity to campaign during the time up to the Election and at the "meet and greet" at the Annual Meeting, currently scheduled for November 19, 2025. Candidate Bios, which are paid for and distributed by the HOA, are not campaign literature. Campaign literature may not be posted on the Tanterra HOA website and/or Tanterra HOA Facebook Page. Campaign materials may be distributed using mailing labels that are available for this purpose by purchase from the Clerk of the HOA for \$25.00.
