2025 ELECTION RULES

The Election Committee is comprised of Jim Frye, Julie Funt and Beth Murray. These individuals will be checking in homeowners and/or examining and tabulating the votes.

The first 10 minutes of the Annual Meeting, currently scheduled for November 19, 2025, will be allotted for a "Meet and Greet" of the candidates for the Board of Directors. During the Annual Meeting, and prior to the Election voting, each candidate will be allowed up to two minutes to explain why they should be elected to the Board. Comments will be kept to why they are suited for the position, what experience they have that would make them a good Board Member, how long they have lived in the neighborhood, what they would like the Board to do, etc. Essentially, they will be providing the Candidate Bio information that was included in the Newsletter. Other candidate backing and/or bashing will not be permitted (one candidate cannot say anything good or bad about another candidate's position on an issue). Candidates will be speaking in alphabetical order per their last name.

The Candidates receiving the highest three vote totals, including absentee ballot votes, will be declared the winners of the Election. In the event of a tie between the 3rd place finishers, the following will take place: in the event one of the candidates does not acquiesce to allow the other to have the Board Member position, a run-off election between the tying candidates will take place by a secret ballot at the Annual Meeting. No additional comments by the candidates will be allowed. Slips of paper will be distributed and homeowners in attendance will vote (one per household) by writing the name of the candidate they are voting for on the slip and depositing it in the ballot box. These votes will be added to absentee ballot votes that were received for each run-off candidate and the highest vote total will receive the position. In the event a tie still remains at this point, a coin flip will determine the winner.

Following the announcement of the Election Results, those members of the Election Committee attending the Annual Meeting, currently scheduled for November 19, 2025, will certify the Election Results.

Hi, my name is Glen McEwen and I am running for one of the open positions of the Tanterra Board of Directors.

I have been a Tanterra homeowner for over 36 years. During that time, my wife Gina and I first started serving the community by being on the Social Committee and then later chaired the same committee. I have also filled in on the Architectural Committee when needed. In addition, I have also served the residents of Tanterra by being on the Board of Directors for over the last 18 years, serving first as the Vice President and then the last 12 years as President. I also help out yearly on pool cleanup days in the spring and stack chairs and put away the pool furnishings every Labor Day (not to mention cooking hot dogs on the holidays!). My efforts on behalf of the HOA have involved a lot of work, but it is also a labor of love since I think Tanterra is one of the best neighborhoods there is and I believe my volunteering, as well as those others that volunteer, help keep it that way.

Every spring, adjacent neighborhoods with community swimming pools have signs advertising pool memberships are available. However, in Tanterra, we have a 2-year waiting list of families that want to join our pool. I believe that this is a reflection of the wonderful social atmosphere at Tanterra which comes from the hard work of our Board and volunteers. I believe the social aspects of the neighborhood are what keeps the associate members coming back and, in turn, keeps our dues low. Please feel free to check the websites of neighboring communities for their dues and you will find Tanterra has one of the lowest.

The hard working 5% of the homeowners that perform 95% of the work have saved the homeowners association tens of thousands of dollars over the years (and this excludes the savings that our self-managed Board saves the homeowners). There have been a lot of changes made to improve the neighborhood over the past years which would not be possible without the hard work of the Board and the neighborhood volunteers, and I am proud to say that I took part in the changes.

I would really appreciate your vote so I can continue serving the neighborhood and we continue having Tanterra be as great as it is!

THE CANDIDATES

WAYNE JOHNSON

My name is Wayne Johnson and I am seeking re-election to the Board of Directors. I have been on the Board of Directors since 1992 and currently serve as the Vice President.

I have been a Tanterra homeowner since 1986 and am fully retired. I previously worked for 13 years as a Laboratory Scientist at Medstar Montgomery, 12 years at a small laboratory in Gaithersburg, and 20 years in the Army.

In addition to serving on the Board since 1992, I have also been the Pool Committee Chair since 1994 (except for three years when I served as President of the Board), and currently serve as Chair of the Architectural and Adult Beverage Committees as well. I have served as Chair of the Grounds and Tennis Committees when those positions were vacant. Prior to serving on the Board, my wife and I served together on the Social Committee. I have initiated and written drafts of charters for all the Tanterra Committees. The charters explain the functions and authority of each committee.

To save our HOA money, I organize volunteers to work at the pool every Spring. The volunteers and I have removed and replaced rotten siding on the sheds and pool house, painted walls, doors, railings and fence posts, removed and replaced hundreds of feet of caulking each year, power washed the pool decks, varnished posts on the pavilion, cleaned drainage channels, installed new siding on the snack bar shed, replaced the entire fabric of the chain link pool fence, and trimmed trees and vines, among other items. What we did not get done on those workdays, I did myself during the week. Fortunately, in recent years, a small number of fellow retirees have begun to lend their hand in helping me during the week, which is much appreciated. Every year I refurbish about 20 to 40 lounge chairs with new straps and volunteer well over 100 hours of my time every year.


I have initiated, planned, or supervised (usually all three) the following projects: pool house renovation (we had a committee plan it); build the snack bar/meeting building, swim/dive team and storage buildings, stone wall at the baby pool, corn hole area and patio in front of the snack bar; tennis court renovation; pool renovation (a committee was also formed to plan and review bids); new roof and vinyl siding on the pool house; and new roof on the pavilion. Although we have not done so in recent years, I have organized and participated in the clean up of the common grounds, which is mostly cutting tree limbs and whole trees that have fallen and picking up debris.

In closing, I ask for - and would greatly appreciate - your vote this November 19th so that I may continue to serve the Tanterra community as a member of its Board of Directors.

BOARD MINUTES - September 17, 2025

TANTERRA HOMEOWNERS ASSOCIATION, INC. Board of Directors Meeting September 17, 2025

September 17, 2025 (Approved 10/15/2025) ZOOM Meeting

1. CALL TO ORDER/ESTABLISH QUORUM

The Meeting was called to order at 7:33 PM by Vice President Wayne Johnson.

2. ADDITIONS/CHANGES TO THE AGENDA by the BOD

None.

3. HOMEOWNER'S FORUM

4. APPROVAL OF MINUTES

A motion was made by Glenn Wasik to approve the August 20, 2025 BOD Meeting Minutes. The motion was seconded by Dave Bouve. The motion passed unanimously.

5. REVIEW OF FINANCIALS

Jim Cagley reviewed the outstanding payments and dispositions. There are currently 5 unpaid Homeowners and there are six (6) extensions of payment. Reported major expenditures since the last meeting: Pool Management Fees - \$30,100.00; Pool Utilities - \$2,362.98; and Grounds – Mowing \$1,200.00. The Swim & Dive Team account balance is \$49,860.72. The Finance Committee held a Meeting to discuss and develop the 2025 Budget and other matters of financial concern on September 4, 2025.

There was a presentation by the Finance Committee and discussion regarding the proposed 2026 Budget from the Committee's September 4, 2025 Meeting. Jim Cagley covered the items line by line and input was received from Board Members and other Committee Chairs/Members present. There was a discussion about capital improvement items proposed for 2026 and past and future Reserve Fund usage. The 2025 Recommended Annual Reserve Funding level is \$50,443.00. Jim Wenhold moved to publish the 2026 Draft Budget to the Homeowners as presented in the October 2025 issue of Tanterra Today. The motion was seconded by Glenn Wasik. The motion passed unanimously.

6. REPORTS

Architectural Committee – Wayne Johnson

Wayne Johnson reported there were three (3) approvals for an architectural change at the September 2025 Meetings. There was one (1) denial of a request for a metal roof. Only four (4) of nine (9) landscaping violations have been corrected.

No Pool Committee Meeting was held during this last period.

The Pool has been undergoing season closing procedures.

Grounds Committee - Diana Cortijo

No Grounds Committee Meeting held during this last period.

The front entrance area has been cleaned up. Diana submitted estimates for common ground tree trimming/removal. The matter was tabled.
